Thank you for your letter to Ian Bancroft dated 19 December 2022 regarding the Shared Prosperity Fund (SPF).

We are currently in the process of developing the Wrexham Strategy and timeline for the SPF programme; the details of which should become clearer in the next month. As a result, I am not in a position to outline the specifics of the programme. However, I can update you on where we are up to so far.

The application process for round one will commence w/c 9 January 2023. The draft application and guidance being made available on our webpage for all applicants to have the opportunity to prepare and ask any questions prior to their submissions. We anticipate that the final application process will commence w/c 30 January 2023. There will be a two/three week submission window and then the round one of the applications will close.

All applications will be subject to panel reviews with successful applicants being invited to provide further information for stage two of the application process. We expect there will be another round of applications commencing in April 2023.
